I. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

, United States Army, for action on 29 October 1969, while a member of HHC, 1st Brigade, 5th Infantry Division. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II. SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:
