I. . . SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Captain *David A. Cox*, (then First Lieutenant), Infantry, United States Army, for action on 26 April 1971, while a member of Company B, 1st Battalion, 20th Infantry, 11th Infantry Brigade, 23d Infantry Division, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Lieutenant Colonel *Larry D. Evans*, (then Captain), Infantry, United States Army, for action on 2 May 1968, while a member of Company D, 1st Battalion, 8th Cavalry, 1st Cavalry Division, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

II. . . LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

General *Herman F. Zeiner Gundersen*, Army of Norway, April 1977 to June 1980.

Colonel General *Dusan Pekic*, Army of Yugoslavia, January 1975 to June 1980.

Lieutenant General *Ernst Rebentisch*, , Army of the Federal Republic of Germany, 1 October 1970 to 31 March 1980.

General *Nils Gunnar Skold*, Army of Sweden, October 1976 to September 1980.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Colonel *Norberto Gutierrez Aragon*, , Spanish Army, June 1977 to June 1980

Brigadier General *Charles G. Fricaud-Chagnaud*, French Army, September 1975 to June 1978.

Major General *Yousif Hassan el Hag*, Sudanese Army, February 1978 to February 1980.

Colonel *Franz Nahrgang*, Army of Austria, August 1973 to August 1979.

Major General *Noh Young Park*, Republic of Korea Army, October 1976 to October 1979.

Major General *Guillermo Ruiz Perez*, Mexican Army, May 1976 to February 1978.

Brigadier General *Juan Evangelista Zapata*, Army of Venezuela, February 1976 to August 1979.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Colonel *Heribert Brandstetter*, , Army of the Federal Republic of Germany, 1 August 1975 to 30 March 1980.

III. . . SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to:

Private First Class *Duilio A. Sanabria*, , United States Army, for heroism on 2 April 1980, while a member of the 21st Evacuation Hospital, 13th Corps Support Command, Fort Hood, Texas.

IV. . . SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Second Lieutenant *Jeffrey S. Bittel*, , Field Artillery, United States Army, for heroism on 6 March 1980, while a member of Battery B, 6th Battalion (LANCE), 33d Field Artillery, Fort Sill, Oklahoma.

Private First Class *Ricky V. Carr*, , United States Army, for heroism on 23 April 1980, while a member of G Troop, 2d Squadron, 3d Armored Cavalry Regiment, Fort Bliss, Texas.

Specialist Six *Jackye Q. Chalk*, , United States Army, for heroism on 27 April 1979, while a member of Company B, Troop Command, Brooke Army Medical Center, Fort Sam Houston, Texas.

Sergeant Major *Gilbert G. Chipps*, , United States Army, for heroism on 29 April 1980, while a member of United States Army Element, Pacific Command, J-1, Camp Smith, Hawaii.

Staff Sergeant *Jose A. Delapaz*, , United States Army, for heroism on 17 March 1980, while a member of the Basic Training Committee Group, United States Army Training Center and Fort Dix.

Private First Class *Edilvian Diaz-Perez*, , United States Army, for heroism on 2 April 1980, while a member of Headquarters and Headquarters Company, 1st Battalion (M), 41st Infantry, 2d Armored Division, Fort Hood, Texas.

Specialist Four *David A. Hoffman*, , United States Army, for heroism on 7 December 1979, while a member of 1st Battalion, 9th Infantry, 2d Infantry Division, Korea.

Specialist Four *David E. Hunsucker*, , United States Army, for heroism on 17 November 1979, while a member of Company A, 548th Engineer Battalion (Combat) (Heavy), Fort Bragg, North Carolina.

Sergeant First Class *James W. Klewicki*, , United States Army, for heroism on 5 February 1980, while a member of United States Army Institute for Military Assistance, Fort Bragg, North Carolina.

Staff Sergeant *Jessie K. Landkrohn*, , United States Army Air Corps, for heroism on 5 October 1944, while a member of Training Command, 2d Air Force, Clovis Army Air Field, New Mexico. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Lieutenant Colonel *John P. Lawton*, , Infantry, United States Army, for heroism on 13 February 1980, while a member of 2d Battalion, 3d Basic Training Brigade, Fort Dix, New Jersey.

Sergeant First Class *Steven M. Sutton*, , United States Army, for heroism on 27 April 1979 while a member of Company B, Troop Command, Brooke Army Medical Center, Fort Sam Houston, Texas.

Specialist Four *Morris O. Waters*, , United States Army, for heroism on 4 June 1980, while a member of Company B, 40th Signal Battalion (Construction) Fort Huachuca, Arizona.

Sergeant First Class *William S. Werther*, , United States Army, for heroism on 6 October 1979, while a member of Third Reserve Officers Training Corps Region, Senior Program, University of South Alabama.

Staff Sergeant *Edward Williams*, , United States Army, for heroism on 4 June 1980, while a member of Company B, 40th Signal Battalion (Construction), Fort Huachuca, Arizona.

V. . . BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" Device for heroism in connection with military operations against hostile forces is awarded to:

Specialist Five *Charles R. Love*, (then Specialist Four), United States Army, for heroism in May 1969, while serving as a member of Reconnaissance Platoon, Headquarters Company, 2d Battalion, 47th Infantry, Republic of Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

Major *James T. O'Kelley, Jr.*, (then Captain), United States Marine Corps Reserve, for heroism on 22 March 1968, while serving with the 1st Battalion, 6th Infantry, Americal Division, Vietnam. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

VI. . . ARMY COMMENDATION MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded posthumously to:

Lieutenant Colonel *Richard Friess*, , Army of the Federal Republic of Germany, 1 May 1976 to 20 October 1979.

VII. . . ARMY COMMENDATION MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:

Sergeant Major *Peter Siegfried Aschenbrenner*, , Army of the Federal Republic of Germany, 3 June 1975 to 27 April 1980.

Lieutenant Colonel *Hans Ermlich*, , Army of the Federal Republic of Germany, 5 May 1975 to 1 April 1980.

Lieutenant Colonel *Manfred Knapp*, , Army of the Federal Republic of Germany, 1 October 1977 to 31 March 1980.

First Lieutenant *Georg Muller*, , Army of the Federal Republic of Germany, 16 July 1979 to 1 October 1980.

First Lieutenant *Yoon Young Soo*, , Republic of Korea Army, 1 December 1978 to 1 June 1980.

Master Sergeant *Angel Gandarillas Suarez*, , Army of Bolivia, 28 February 1978 to 1 March 1980.

Colonel *Lee Yung Woo*, , Republic of Korea Army, 1 May 1979 to 20 February 1980.

First Lieutenant *Park Hwa Young*, , Republic of Korea Army, 27 March 1979 to 1 February 1980.

VIII. . . BRONZE STAR MEDAL. So much of Section IV, General Order, 1974, Headquarters, Department of the Army, Washington, DC, as pertains to the award of the Bronze Star Medal with "V" Device to Staff Sergeant *Julius Maynard*, , United States Army, as reads: "for action on 24 August 1962" is amended to read "for action on 15 August 1971."

IX. . . AIR MEDAL. So much of Section IX, General Orders Number 12, 1976, Department of the Army, Washington, DC, as pertains to award of the Air Medal with "V" Device to First Lieutenant *Raffaele A. Sassi*, , Armor, United States Army, for action on 12 October 1972, as reads Air Medal with "V" Device is amended to read "Air Medal (Twenty-Third Award) with "V" Device.

X. . . UNITS ENTITLED TO BATTLE CREDITS. So much of War Department General Orders 99, 6 November 1945, as pertains to units awarded battle participation credits during campaign "Rome-Arno" as reads "21st Traffic Regulating Group" is deleted.
