I. .SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded posthumously to:

Captain *Charles H. King*, , Field Artillery, United States Army, for action on 21 October 1918, while a member of the 105th Field Artillery, France. This award is authorized under the provisions of paragraph 2-10, AR 672-5-1.

II. .SILVER STAR. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Technician Fifth Grade *Patsy Mantini*, , United States Army, for action from 12 through 13 September 1944, while a member of Company K, 22d Infantry. This award is authorized under the provisions of paragraph 1-13, AR 672-5-1.

III. .LEGION OF MERIT. 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

General *Jose Ferraz da Rocha*, Brazilian Army, January 1980 to March 1981.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order, 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Brigadier General *Hans-Ulrich Flade*, , Air Force of the Federal Republic of Germany, 1 October 1976 to 10 September 1980.

Colonel *Abraham Willem Schulte*, Netherlands Army, July 1979 to August 1980.

Major General *Anders Christian Bugge Vegger*, Royal Danish Army, 1 January 1976 to 31 October 1980.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Colonel *Henk R. Toorop*, 24 July 1977 to 31 December 1980, the Royal Netherlands Army.

IV. .ARMY COMMENDATION MEDAL. By direction of the Secretary of the

Army, under the provisions of paragraph 2-18, AR 672-5-1, the Army Commendation Medal for meritorious service is awarded to:

Lieutenant Colonel *Juergen M. W. Erbe*, Army of the Federal Republic of Germany, 29 August 1977 to 19 September 1980.

Major *Hong Jin Ho*, , Republic of Korea Army, 6 October 1978 to 11 October 1980.

Colonel *Philippe N. Patricot*, French Army, 10 August 1977 to 31 August 1980.

Major *Park Kun Yung*, , Republic of Korea Army, 1 October 1978 to 31 January 1981.

V. . MERITORIOUS UNIT COMMENDATION. 1. So much of paragraph 5, General Orders 68, 1953, Department of the Army, Washington, DC, as reads: "The 34th Replacement Company, Inchon Replacement Depot, 8057th Army Unit, formerly the 510th Replacement Company, 110th Replacement Battalion, is cited . . . is amended to read: "The 510th Replacement Company, 110th Replacement Battalion is cited"

2. So much of paragraph 22, section II, Department of the Army General Orders 48, 1968, as amended by paragraph 3, section II, Department of the Army General Orders 70, 1969, pertaining to award of the Meritorious Unit Commendation to the 173rd Airborne Brigade (Separate) and its assigned and attached units, is amended to delete Company A, 82d Aviation Battalion (for the period 1 August 1966 to 31 January 1967).

VI. . UNITS ENTITLED TO BATTLE CREDITS. 1. So much of War Department General Orders Number 118, 1945, pertaining to campaign participation credit for Rhineland, is amended to delete the 62d Traffic Regulating Battalion.

2. So much of War Department General Order 12, 1946, pertaining to campaign participation credit for Ryukyus, as reads: "91st Chemical Mortar Battalion" is amended to read: "91st Chemical Mortar Company."
