I—DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action in connection with military operations involving conflict with an armed hostile force is awarded to:

Master Sergeant *William E. Bercaw*, (then Platoon Sergeant, United States Army), for actions on 2 May 1970 while serving with Headquarters and Headquarters Company, 2d Battalion, 34th Armor, 25th Infantry Division. Master Sergeant Bercaw distinguished himself while leading a four-vehicle armed convoy toward a rendezvous with forward allied elements located in Cambodia. Master Sergeant Bercaw was riding aboard the lead vehicle when a sudden burst of enemy fire swept through the lead element. The commander of the lead vehicle was mortally wounded by the fire and Master Sergeant Bercaw suffered a painful arm wound. Nevertheless, Master Sergeant Bercaw immediately assumed command of the vehicle and organized the confused crew into an effective fighting unit. While directing the fire of his men, he crawled across an exposed portion of his vehicle to man an automatic weapon. Although seriously wounded, he continued to fire the weapon until he exhausted his ammunition. He then secured the tank commander's rifle and expended all available ammunition toward the enemy. During the entire contact, Master Sergeant Bercaw continuously exposed himself to the hail of enemy fire in order to direct the actions of his men and move the convoy out of the contact area. Although wounded three times, his determined actions enabled the convoy to depart the contact area while suffering only minimal casualties. Master Sergeant Bercaw's extraordinary heroism and devotion to duty were in keeping with the highest traditions of the military service and reflect great credit upon himself, his unit, and the United States Army. (These General Orders supersede the award of the Distinguished Service Cross to Master Sergeant William E. Bercaw as announced in General Orders Number 5006, Headquarters, United States Army, Vietnam, APO San Francisco 96375, dated 4 November 1970.)

II—LEGION OF MERIT. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious service is awarded to:

III—SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant *Thomas P. Barnes*, United States Army, for heroism on 15 May 1989, while assigned to the 3d Platoon, 564th Military Police Company, Federal Republic of Germany.

First Lieutenant *Daniel M. Dent*, United States Army, for heroism on 10 September 1988, while assigned to Outlaw Troop, 4th Squadron, 3d Armored Cavalry Regiment, Fort Bliss, Texas.

Staff Sergeant *Michael D. George*, United States Army, for heroism on 10 December 1988, while assigned to I Troop, 3d Squadron, 116th Armored Cavalry Regiment, Pendleton, Oregon.

Staff Sergeant *Douglas C. Kay*, United States Army, for heroism on 28 August 1988, while assigned to 63rd Medical Detachment, Federal Republic of Germany.

Private First Class *Terry E. Moore*, United States Army, for heroism on 8 March 1988, while assigned to Company B, 2d Battalion, 502 Infantry Regiment, 101st Airborne Division Air Assault, Fort Campbell, Kentucky.

Sergeant *Dale E. Skaggs*, United States Army, for heroism on 2 April 1988, while assigned to Armed Forces Institute of Pathology, Walter Reed Army Medical Center, Washington, DC.

Sergeant *Gary M. Smith*, United States Army, for heroism on 9 July 1988, while assigned to Headquarters, State Area Command, Idaho Army National Guard.

IV—MERITORIOUS SERVICE MEDAL. By direction of the Secretary of the Army, under the provisions of AR 672-5-1, paragraph 2-17, the Meritorious Service Medal for meritorious service is awarded to:

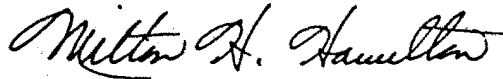
